Please refer to your letter C.No. AICEIA/Shg.Circle/SH/2019/A-193 dated 23.12.2019.

The contents of this letter have been taken note of. I have been directed to inform you as follows:

1. Request for including the vacancy year 2020 as well while convening the impending DPC for giving promotion to eligible Inspectors to the grade of Superintendent:

DPC for filling of vacancies in the grade of Superintendent for the year 2020 will be convened shortly after deciding on the representations on Seniority of some of the Inspectors as per the directions of Hon'ble CAT.

2. Designated Office Space allocation for various categories of officers and staff as per Central Govt. norms:

It is advised to pursue with Jurisdictional Commissioner to get this issue addressed and all the Commissioners in the Zone have already been instructed on the subject.

3. On matter relating to grievances of many officers(Inspectors) in the Zone:

Administration is the competent authority to dispose staff grievance. It is not an advisory body to any service association to direct officers to approach the associations. Looking into the serious verbal complaints made by numerous Inspectors to this office, it has now become necessary to find whether the Shillong Circle of AICEIA is truly representative and duly elected body in accordance with your constitution. The claim to have been unanimously elected with proper quorum shall be substantiated with the record of your election proceedings. It is advised to submit to this office a copy of Election proceedings, clearly depicting the quorum of members participated in the election held on 30.10.2018 by 10.01.2020; failing which no credence will be given to the correspondences made by Shillong Circle of AICEIA in future.
