The Direct Recruit Inspectors who could not pass the Departmental Examination in full within two years of joining in the grade will not be eligible for further increment.

2. जो पदोन्नत अधिकारी ग्रेड में शामिल होने के एक वर्ष के भीतर विभागीय परीक्षा पूरी तरह से उत्तीर्ण नहीं कर सके, वे आगे वेतन वृद्धि के लिए पात्र नहीं होंगे।

The Promotee Officers who could not pass the Departmental Examination in full within one year of joining in the grade will not be eligible for further increment.

3. **परीक्षा उत्तीर्ण करने में बार-बार असफल होने पर सीधे भर्ती किए हुए अधिकारी के मामले में नियुक्ति रद्द होगी और अन्य मामलों में निचले पद पर वापसी होगी।**

Repeated failure to pass the examination will entail loss of appointment in the case of directly recruited officer and reversion to the lower post in the case of others.
