However, this promotion is subject to the outcome of the Review DPC to be conducted as per CAT, Chandigarh and Patna Benches judgments dated 05.05.2006 and 06.02.2007 communicated vide Ministry's letter F. No. A-32012/4/2000-Ad.II-B (Vol. IV) dated 25.04.2007 and the same has been kept in abeyance as per Ministry's letter dated 08.10.2007.

The above officers are not entitled to get the benefit of pay fixation as they had already been granted Second / Third financial up-gradations under the MACP Scheme respectively vide Establishment Orders No. 59/2011 dated 22.12.2011, No. 50/2011, dated 20.12.2011 and No. 73/2010 dated 08.04.2010.

The Seniority of the above officers in the grade of Superintendent will be fixed in the order shown above.

In the event of refusal of promotion they would be debarred from promotion for a period of one year.

**NOTE:** In the event of repatriation of any officers(s) who is/are on deputation, or in the event of any Court's Order, the junior most officer(s) in the above promotion order will be reverted.

### PART – II: TRANSFER AND POSTING

On promotion, all the officers are temporarily retained at their present places of posting. Posting order will be issued separately.
