PART – I:

PROMOTION

Smt. K.M. Syiemlieh, Inspector of Central Excise, is hereby promoted to the grade of Superintendent (Group 'B' Gazetted) in PB-2 ₹ 9300-34800 with Grade Pay of ₹ 4800 with effect from the date she assumes charges of higher post at her place of posting as shown below in Part-II of this order.

However, this promotion is subject to the outcome of the Review DPC to be conducted as per CAT, Chandigarh and Patna Benches judgments dated 05.05.2006 and 06.02.2007 communicated vide Ministry's letter F. No. A-32012/4/2000-Ad.II-B (Vol. IV) dated 25.04.2007 and the same has been kept in abeyance as per Ministry's letter dated 08.10.2007.

Smt. K.M. Syiemlieh is not entitled to get the benefit of pay fixation as she had already been granted second financial up-gradation under the Erstwhile ACP Scheme vide Establishment Order No. 52/2007, dated 02.07.2007.

The Seniority of Smt. Syiemlieh in the grade of Superintendent shall be below Dr. Satyen Roy and above Shri Lila Phukan.

In the event of refusal of promotion, she would be debarred from promotion for a period of one year.

On promotion, Smt. K.M. Syiemlieh is placed at the disposal of the Commissioner of Customs (P), NER, Shillong. The officer shall accordingly report to the concerned Commissioner.
