Shri Satyen Roy is not entitled to get the benefit of pay fixation as he had already been granted financial up-gradations under the ACP/ MACP Scheme vide Establishment Orders No.136/2003 dated 18.06.2003 & No.59/2011 dated 22.12.2011.

The Seniority of Shri Roy in the grade of Superintendent will be placed below Shri Ranjit Kr. Das, Superintendent.

In the event of refusal of promotion he would be debarred from promotion for a period of one year.

<u>NOTE:</u> In the event of repatriation of any officers(s) who is/are on deputation, or in the event of any Court's Order, the junior most officer(s) in the above promotion order will be reverted.
