However, this promotion is subject to the outcome of the Review DPC to be conducted as per CAT, Chandigarh and Patna Benches judgments dated 05.05.2006 & 06.02.2007, communicated vide Ministry's letter F. No. A-32012/4/2000-Ad.II-B (Vol. IV) dated 25.04.2007 and the same has been kept in abeyance as per Ministry's letter dated 08.10.2007.

The above officers are not entitled to get the benefit of pay fixation as they have already been granted 2nd financial up-gradation under the ACP Scheme vide Estt. Order No. 52/2007 dated 02.07.2007 and No.82/2007 dated 17.10.2007, involving Grade Pay of ₹ 4800.

The seniority of the officers in the grade of Superintendent shall be in the order shown above.

In the event of refusal of promotion, they would be debarred from promotion for a period of one year.

Note: In the event of repatriation of officer(s) who is / are on deputation, or in the event of nay Court's order, the junior-most officer(s) in the above promotion order shall be reverted.
