**PART – I:**

**PROMOTION**

Shri Jayanta Kumar Hazarika, Inspector of Central Excise, is hereby promoted to the grade of Superintendent (Group 'B' Gazetted) in PB-2 ₹ 9300-34800 with Grade Pay of ₹ 4800 with effect from the date he assumes charges of higher post at the place of posting shown below in part-II of this order.

However, this promotion is subject to the outcome of the Review DPC to be conducted as per CAT, Chandigarh and Patna Benches judgments dated 05.05.2006 & 06.02.2007, communicated vide Ministry's letter F. No. A-32012/4/2000-Ad.II-B (Vol. IV) dated 25.04.2007 and the same has been kept in abeyance as per Ministry's letter dated 08.10.2007.

The above officer is not entitled to get the benefit of pay fixation as he has already been granted 3<sup>rd</sup> financial up-gradation under the MACP Scheme vide Estt. Order No. 155/2012 dated 28.09.2012, involving Grade Pay of ₹ 4800.

In the event of refusal of promotion, he would be debarred from promotion for a period of one year.

*Note: In the event of repatriation of officer(s) who is /are on deputation, or in the event of nay Court's order, the officer shall be reverted.*
