PART - I:

PROMOTION

Shri. Salew Adani, Inspector of Customs & Central Excise is hereby promoted to the grade of Superintendent (Group 'B' Gazetted) in the Pay Scale of ₹ 9,300 - 34,800/- in PB-2 with GP of ₹ 4,800/- on regular basis with effect from the date he assume charges of higher post at the place of posting shown below in part-II of this order.

However, this promotion is subject to the outcome of the Review DPC to be conducted as per CAT, Chandigarh and Patna Benches judgments dated 05.05.2006 & 06.02.2007, communicated vide Ministry's letter F. No. A-32012/4/2000-Ad.II-B (Vol. IV) dated 25.04.2007 and the same has been kept in abeyance as per Ministry's letter dated 08.10.2007.

The above mentioned officer shall not be entitled to get the benefit of pay fixation as he has already been granted 2nd financial up-gradation under the MACP Scheme involving Grade Pay of ₹ 5,400/- vide Establishment Order No.142/2015.

In the event of refusal of promotion, he would be debarred from promotion for a period of one year.

On promotion, Shri. Salew Adani is hereby posted to Central Excise & Service Tax Commissionerate, Dibrugarh. Accordingly, he may be relieved immediately from his present place of posting so as to enable him to join his new place of posting on promotion.
