However, this promotion is subject to the outcome of the Review DPC to be conducted as per CAT, Chandigarh and Patna Benches judgments dated 05.05.2006 & 06.02.2007, communicated vide Ministry's letter F. No. A-32012/4/2000-Ad.II-B (Vol. IV) dated 25.04.2007 and the same has been kept in abeyance as per Ministry's letter dated 08.10.2007.

The above officers at Sl.No. 3-4, 6-11, 17-20, 22, 24-26, 39-49, 51, 53, 55-56, 58-62, 64-66, 69-70, 72-78, 81-82, 84-85, 87-88, 90-91, 93, 95, 102-107 and 113 are not entitled to get the benefit of pay fixation as they have already been granted financial up-gradation involving GP of ₹4800/- and ₹5400/- under ACP/MACP Scheme.

The seniority of the officers in the grade of Superintendent shall be in the order shown above.

In the event of refusal of promotion, they would be debarred from promotion for a period of one year.
