#### **PROMOTION**

However, this promotion is subject to the outcome of the Review DPC to be conducted as per CAT, Chandigarh and Patna Benches judgments dated 05.05.2006 & 06.02.2007, communicated vide Ministry's letter F. No. A-32012/4/2000-Ad.II-B (Vol. IV) dated 25.04.2007 and the same has been kept in abeyance as per Ministry's letter dated 08.10.2007.

The above officers except at Sl.No. 5, are not entitled to get the benefit of pay fixation as they have already been granted  $1^{\rm st}$ /  $2^{\rm nd}$ /  $3^{\rm rd}$  financial up-gradation under the ACP / MACP Scheme vide Establishment Orders No. 125/1999 dated 02.11.1999, 82/2007 dated 17.10.2007, 100/2010 dated 16.06.2010 and 113/2013 dated 16.09.2013 involving Grade Pay of ₹ 4800 / ₹ 5400.

However, the officer at Sl.No.5 is hereby asked to exercise option under FR 22 (I) (a) (1), within one month from the date of promotion, to get his pay fixed in the higher post whether from the date of promotion or from the date of his next increment. Option once exercised shall be final.

The seniority of the officers in the grade of Superintendent shall be in the order shown above.

In the event of refusal of promotion, they would be debarred from promotion for a period of one year.
