No. A-32012/4/2000-Ad.II-B (Vol. IV) dated 25.04.2007 and the same has been kept in abeyance as per Ministry's letter dated 08.10.2007.

The above mentioned officers appearing at Sl. No. 1, 2 & 10 are not entitled to get the benefit of pay fixation as they have already been granted financial up-gradation involving GP of ₹4,800/- under the ACP/MACP Scheme, other officers are hereby asked to exercise option for pay fixation under FR 22 (I) (a) (1), within one month from the date of promotion. Option once exercised shall be final.


