No. 2 & 6 are not entitled to get the benefit of pay fixation as they have already been granted financial up-gradation involving GP of ₹4,800/- under ACP/MACP Scheme vide this office Establishment Order Nos. 83/2008 dated 11.11.2008 and 101/2010 dated 16.06.2010 respectively.

The officers at Sl. No. 1, 3, 4 & 5 are hereby asked to exercise option for pay fixation under FR 22 (I) (a) (1), within one month from the date of promotion. Option once exercised shall be final.

The seniority of the above mentioned officers in the grade of Superintendent shall be in the order shown above.


In the event of refusal of promotion, they would be debarred from promotion for a period of one year.
