However, the officers except at Sl.No.24 are not entitled to get the benefit of pay fixation as they have already been granted financial up-gradation involving Grade Pay of ₹ 1900 / ₹ 2000 under the ACP/MACP Scheme.

In the event of refusal of promotion they would be debarred from promotion for a period of one year.
