#### PROMOTION

Shri Thangmuanlal Tonsing, Inspector of Customs & Central Excise is hereby promoted to the grade of Superintendent (*Group 'B' Gazetted*) in the Pay Scale of ₹ 9,300 - 34,800/- in PB-2 with GP of ₹ 4,800/- on regular basis with effect from the date he assume charges of higher post at the place of posting shown below in part-II of this order.

The above mentioned officer is not entitled to get the benefit of pay fixation as he has already been granted financial up-gradation involving GP of ₹4,800/- under the MACP Scheme vide this office Establishment Order No. 101/2010 dated 16.06.2010.

He should join the post on promotion within 15 (Fifteen) days from the date of issue of this order, failing which, it will be treated that he did not accepted the promotion ab-initio and as a consequence he would be debarred from promotion for a period of one year.
