PROMOTION

The seniority of Manoj Kumar Khakholar on promotion as Superintendent will be fixed above Shri K. Khamchinlian and below Shri Probin Kumar Deori, Superintendent.

He is not entitled to get the benefit of pay fixation as he has already been granted financial up-gradation involving GP of ₹5,400/- under the MACP Scheme vide this office Establishment Order No. 86/2015 dated 17.04.2015.

He should join on promotion as Superintendent within 15 (Fifteen) days from the date of issue of this order, failing which, it will be treated that he is not willing to accept the promotion and as a consequence he would be debarred from promotion for a period of one year.

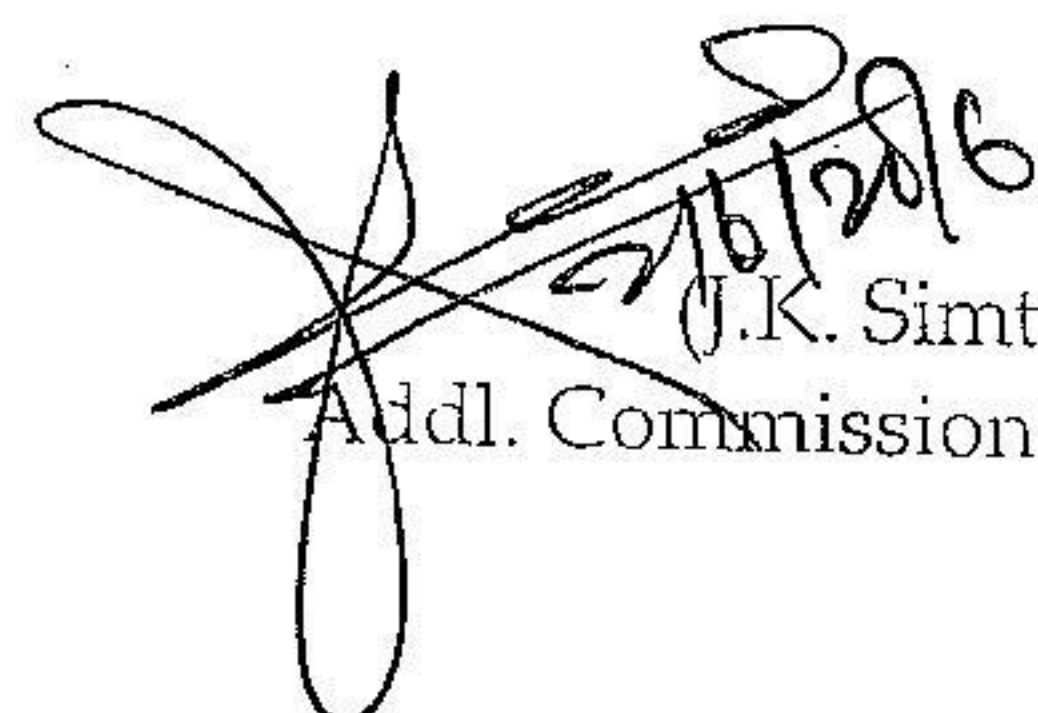
