Subject: Grant of 2nd Financial Up-gradation under the MACP Scheme to Telecom Staff - Order - reg.

In pursuance of the DoP&T's O.M. No. 35034/3/2008 -Estt. (D), dated the 19th May, 2009, Shri Khaidem Bashistha Singh, Radio Operator under Telecom Staff of Customs (P) N.E.R., Shillong is hereby granted 2nd Financial Up-gradation under the Modified Assured Career Progression Scheme as detailed given below:-

The Financial Up-gradations granted to the above officials are subject to, inter-alia, the following conditions:-

The financial up-gradations will not result in change in the designation of the beneficiaries i.e., the financial benefit is granted with the retention of their old designation and the said financial up-gradation shall not confer any privilege related to higher status.

The financial up-gradation under the MACP Scheme shall be purely personal to the incumbent (official) and shall not amount to actual functional promotion of the official concerned. And it shall have no relevance to the inter-se seniority position, and as such, there shall be no additional financial up-gradation for the senior officials on the ground that the junior official has got higher pay scale under the MACP Scheme. The concept of "Senior-Junior" is quite alien to the idea behind the MACP Scheme.

Benefit of pay fixation available at the time of regular promotion shall also be allowed at the time of financial up-gradation under the Scheme. There shall, however, be no further fixation of pay at the time of regular promotion if it is in the same grade pay as granted under MACPS.

Further, while implementing the MACP Scheme, the differences in pay scales on account of grant of financial up-gradation under the old ACP Scheme (of August 1999) and under the MACP Scheme within the same cadre shall not be construed as an anomaly.

The above official shall exercise option under FR 22 (I) (a) (1) to get his pay fixed in the higher grade pay either from the date of his financial up-gradation or from the date of his next increment. Such option (exercisable within one month from the date of receipt of this order) once exercised shall be treated as final.

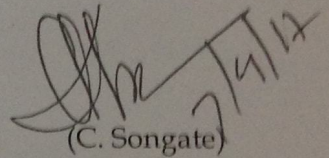
