The above officers are hereby asked to exercise option for pay fixation under FR 22 (I) (a) (1), within one month from the date of promotion. Option once exercised shall be final. However, officers who have already been granted financial upgradation under the ACP/MACP Scheme involving Grade Pay of ₹ 4,800/- or above are not entitled to get the benefit of pay fixation. Hence, no option is required for such officers.


All the above officers should join the post on promotion within 15 (Fifteen) days from the date of issue of this order, failing which, it will be treated that they have not accepted the promotion ab-initio and as a consequence they would be debarred from promotion for a period of one year.
