Hence, no option is required for such officers.

All the above officers should join the post on promotion within 15 (Fifteen) days from the date of issue of this order, failing which, it will be treated that they have not accepted the promotion ab-initio and as a consequence they would be debarred from promotion for a period of one year.


On promotion all the above officers are hereby retained at their existing places of posting for the time being.
