Subject: - Allocation of surplus employees nominated by the Surplus Cell of DOP&T for the post of Inspector - Deemed redeployment in CBEC w.e.f. 21-01-2004 - Order - reg.

The following surplus employees were nominated for redeployment in the post of Inspector of Central Excise and allocated to the cadre controlling zone of Shillong Central Excise vide Board's letter F.No.A-12034/SSC/5/2007-Ad.III(B) dated 03-01-2008. The DOP&T vide Order F.No.10/16/2014-R&R and DC dated 20-07-2015 has granted the benefits of seniority, pay, etc. by treating the 6 Surplus Employees of Delhi Zone who were redeployed during 2008 and 2009 as redeployed as Inspector of Central Excise with effect from 21-01-2004. In pursuance to the above, the Board in consultation with the DOP&T vide letter F.No.A.23020/01/2016-Ad.III(A) dated 29-09-2016 has conveyed its decision to treat the officers similarly placed to the said 6 Surplus Employees mentioned in DOP&T's Order dated 02-07-2015, as redeployed to the post of Inspector of Central Excise w.e.f. 21-01-2004 and their Seniority, and pay to be re-fixed in the terms of the said Order dated 20-07-2015 of DOP&T.
