3. Their promotion is also subject to the relevant conditions prescribed for ad-hoc appointment as stated in DOP&T's OM. No. 28036/8/87-Estt(D) dated 30-03-1988 and the Govt. of India DOPT .A.R. O.M. No. 36011/14/83-Estt(SCT), dated 30-04-1983 and also relevant instructions issued by the Board in this regard from time to time.
4. The above promotions are subject to the final outcome of various pending Court cases.
5. The promotion of the Inspectors of CGST & CX and Customs to the grade of Superintendent are subject to the outcome of various SLPs pending in the Hon'ble Supreme Court on the issue of Seniority in the Grade of Inspectors and any other Orders of Hon'ble CAT/High Courts on the said issue.
6. The officers promoted will not be eligible for the benefit of fixation under FR 22(I) (a) (1) as per the guideline issued by the DoP&T's OM No. 13/02/2017-Estt. (Pay-I) dated 27-07-2017, except for those who have already been granted financial up gradation involving GP of Rs. 4,800/- under MACP Scheme.
7. All the above officers should join the post (in-situ) on promotion within 15 (Fifteen) days from the date of issue of this order, failing which, it will be treated that they have not accepted the promotion ab-initio.

This issues with the approval of the Chief Commissioner.


