Subject: Constitution of Committee on implementation of Rules of Origin under Trade Agreements (FTA/PTA/CECA/CEPA) and verification of Certificates of Origin-reg.

The undersigned is directed to refer to Customs (Administration of Rules of Origin under Trade Agreements) Rules, 2020 (hereafter referred to as the CAROTAR, 2020) issued vide Notification No. 81/2020-Customs (N.T.) dated 21st August, 2020 and Circular 38/2020-Cus, dated 21st August, 2020.

- 2. In order to ensure smooth and uniform implementation of CAROTAR, 2020, it is suggested that a committee may be constituted in each Customs Zone to monitor and assist the Faceless Assessment Group (FAG).
- 3. The proposed committee may constitute of ADC/JC, DC/AC, appraising level officers, including Deputy Director level officer from DRI.
- 4. The important responsibilities of the aforementioned committee may include:
 - (a) Examination of the information provided in Form-I submitted by an importer in terms of rule 5 of CAROTAR, 2020 and check if same is substantiated by the supporting documents. An illustrative list of some of the documents for validating the information is as following:
 - (i) Any document explaining the production process.
 - (ii) Cost sheets indicating various components of value addition, if available.
 - (iii) Where cumulation is being claimed, copies of supporting certificates of origin by other FTA member.
 - (iv) Product catalogue indicating various components of an imported good.

- (v) Proof in form of photographs/website of production facilities in the exporting country and certificate of Business Registration of the exporter.
- (b) Provide guidance and advise to FAG officer on way forward in determining if goods meet originating criteria based upon supporting documents.
- (c) Assists in identifying the additional information or documents which proper officer may seek for verification in terms of rule 6 of CAROTAR, 2020, read with Circular 38/2020-Cus, dated 21st August, 2020.
- 5. The Committee should virtually meet for a short duration every day at a scheduled time to review timeliness of assessment, determination of origin and take measures to remove difficulties.
