ESTABLISHMENT ORDER NO. 50/2022

Dated, Guwahati the 13th of July, 2022

Sub: Grant of 03rd Financial Up-gradation under Modified Assured Career Progression Scheme (MACPS) in the grade of ASI (Weapons), CGST & Customs, Guwahati Zone-Order-reg.

In pursuance of DOP&T's O.M. No. 35034/3/2015-Estt. (D) dated 22.10.2019, Shri Ram Avatar Singh, ASI (Weapons) (Retired) is hereby granted 03rd financial upgradation under MACP Scheme and is accordingly placed in the Pay Matrix Level-4 (Grade Pay-2400) w.e.f 31.08.2019.

Shri Ram Avatar Singh, ASI (Weapons) (Retired) is granted the above benefit in accordance to Para 15 of DOP&T's guidelines issued vide F. No. 35034/3/2015-Estt. (D) dated 22.10.2019 on deferment on financial upgradation and Para 18 of DOP&T's guidelines issued vide F. No. 35034/3/2015-Estt. (D) dated 22.10.2019 regarding the grant of benefit under CCS (CCA) Rules, 1965 in matter of disciplinary proceedings.

The above financial up-gradation is subject to the following conditions:-

1. The financial up-gradation will not result in change in designation of the beneficiary i.e., the financial benefit is granted with the retention of their old designation and the said financial up-gradation shall not confer any privilege related to higher status.
2. The financial up-gradation under the MACP Scheme is purely personal to the incumbent (official) and does not amount to actual functional promotion of the official concerned. It has no relevance to their inter-seniority position, and as such, there shall be no additional financial up-gradation for the senior officials on the ground that the junior official has got higher pay scale(s) under the Scheme. The concept of "Senior-Junior" is quite alien to the idea behind the MACP Scheme.
3. Grant of higher pay-scales(s) under MACP scheme shall be conditional to the fact that the above official, while accepting the aforesaid financial benefits, shall be deemed to have given their unqualified acceptance for promotion on occurrence of vacancy subsequently.
4. Benefit of pay fixation available at the time of regular promotion is allowed at the time of financial up-gradation under the Scheme. There shall, however, be no further fixation of pay at the time of regular promotion if it is in the same Level of Pay Matrix as granted under MACP. However, at the time of actual promotion if it happens to be in a post carrying higher Level in Pay Matrix than what is available under MACPS, no pay fixation would be available and only difference in Level of Pay would be made available.
5. The above official shall exercise option under FR 22(I) (a) (1) to get their pay fixed in the higher Pay Level either from the date of their up-gradation or from the date of their next increment. Such option (exercisable within one month from the date of receipt of this order) once exercised shall be treated as final.
