3. Their promotion is also subject to the relevant conditions prescribed for ad-hoc appointment as stated in DOP&T's OM. No. 28036/8/87-Estt(D) dated 30-03-1988 and the Govt. of India DOPT A.R. O.M. No. 36011/14/83-Estt(SCT), dated 30-04-1983 and also relevant instructions issued by the Board in this regard from time to time.

4. The above promotions are subject to the final outcome of relevant matters pending in any judicial fora.

5. The Promotion of the Inspectors to the grade of Superintendent are subject to finalization of Seniority in the grade in terms of relevant OM's of DOP&T.

6. The officers promoted will not be eligible for the benefit of fixation under FR22(I) (a) (1) as per the guideline issued by the DOP&T's OM No. 13/02/2017-Estt.
