Sub: Promotion in the grade of Driver Grade – I –reg.

I. Promotion:

The following Drivers Grade II of this Zone are hereby promoted to Driver Grade I (Group 'C' Non-Gazetted/Non-Ministerial) in Level 5 in the Pay Matrix (Rs. 29,200 – Rs. 92,300) with effect from the date he assumes charges of higher post at his present place of posting.

However, officers who have already been granted financial up-gradation under the MACP scheme in Level 5 of Pay Matrix (Rs. 29,200 – Rs. 92,300) or above are not entitled to get the benefit of pay fixation.

In the event of refusal of promotion, the officer would be debarred from promotion for a period of one year.

II. Posting:

The promotions of the officers is made on "IN-SITU" basis i.e. such Drivers, Grade – I, shall continue to work at the same place where they are presently posted until further orders.
