Sub:- Grant of Third Financial Up-gradations under the Modified Assured CareerProgression (MACP) Scheme to the grade of Assistant Commissioner (Group 'A' Gazetted) - Order regarding.

In pursuance of the DoP&T's O.M. No. 35034/10/2011 - Estt. (D), dated the 13th June, 2012, Shri haresh Nandi, Assistant Commissioner is hereby granted Third Financial Up-gradation under the MACP heme and is accordingly placed in the grade pay as detailed below with effect from the date mentioned

The above financial up-gradation is subject to the following conditions:-

The financial up-gradation will not result in change in designation of the beneficiary, i.e., the financial nefit is granted with the retention of his old designation and the said financial up-gradation shall not afer any privilege related to higher status.

The financial up-gradation under the MACP Scheme is purely personal to the incumbent and does not ount to actual functional promotion of the official concerned. It has no relevance to their inter-se iority position, and as such, there shall be no additional financial up-gradation for the senior officials on ground that the junior officials have got higher pay scale(s) under the Scheme. The concept of "Seniorior" is quite alien to the idea behind the MACP Scheme.

The above official, while accepting the aforesaid financial benefit, shall be deemed to have given his jualified acceptance for promotion on occurrence of vacancy subsequently.

Benefit of pay fixation available at the time of regular promotion is also allowed at the time of financial gradation under the Scheme. Therefore, the pay shall be raised by 3% of the total pay in the pay band the grade pay drawn before the up-gradation in every stage. There shall, however, be no further tion of pay at the time of regular promotion if it is in the same grade pay as granted under MACPS. vever, at the time of actual promotion if it happens to be in a post carrying higher grade pay than what vailable under MACPS, no pay fixation would be available and only difference of grade pay would be

!The above official shall exercise option under FR 22 (I) (a) (1) to get his pay fixed in the higher grade Jeither from the date of up-gradation or from the date of next increment (1st July of the year). Such On (exercisable within one month from the date of receipt of this order) once exercised shall be treated anal. The pay and the date of increment shall be fixed in accordance with clarification no. 2 of Dept. of Enditure's O.M. No. 1/1/2008-1C dated 13.09.2008.
