Sub: Calling for Options for Annual General Transfer in the grade of Superintendent, Inspector, H-Hav/Hav & Ministerial staff-reg.

However, in case of options not submitted / submitted after the stipulated date, the competent authority may decide transfer and posting as deemed necessary on administrative grounds.
