

Subject: Ante-dating of seniority in the grade of Inspector in respect of Shri Majid Alam and Shri Chakreswar Sharma – Order reg.

In terms of Hon'ble Central Administrative Tribunal, Guwahati Bench Order dated 14.11.2017 passed by the in O.A. No. 040/00307/2017, the cases of Shri Chakreswar Sharma and Shri Majid Alam were verified and compared with the 03 applicants of the O.A. No. 182/2011, if they were similarly placed.

On scrutiny / verification it is found that, the 05 (five) applicants of the above 02 (two) O.A.s joined the department at Data Entry Operators, Grade-A in 1994. They were promoted together to Data Entry Operator, Grade-B vide Establishment Order No. 54 dated 03.04.2001. Subsequently, they were promoted to the grade of Inspector (Gr-B Non-Gazetted) vide Establishment Order No. 95/2008 dated 27.12.2008 (by Commissioner of CE, Shillong) and were placed in the **Seniority List of Inspector as on 01.04.2013**, as under after DR & PR ratio. Thus, for all practical purpose, the applicants of O.A. No. 182/2011 and O.A. No. 040/00307/2017 are found to be similarly placed.

Consequent to Hon'ble CAT, Guwahati Order dated 24.01.2014 passed in O.A. No. 182/2011, Shri Dipankar Dutta, Hemankar Roy and Rajat Subhra Sengupta were given the benefit of ante-dating of seniority w.e.f 27.10.2003 vide this office Establishment Order No. 190/ 2014 dated 17.11.2014. The Seniority List of Inspector as on 01.04.2013 was subsequently revised by the draft Seniority List of Inspector as on 01.04.2015, where Shri Dipankar Dutta, Shri Hemankar Roy, Shri Rajat Subhra Sengupta were placed as under.

Since, applicants of O.A. No. 040/00307/2017 (Shri Majid Alam and Shri Chakreswar Sharma) are found to be similarly placed with the applicants of O.A. No. 182/2011 (Dipankar Dutta, Hemankar Roy and Rajat Subhra Sengupta), the former deserve similar benefits of ante-dating seniority as was extended to the later, in terms of the Hon'ble CAT Guwahati Order dated 14.11.2017 (in O.A. No. 040/00307/2017).

As discussed above, Shri Majid Alam and Chakreswar Sharma, Inspectors (PR) merit anti-dating seniority and deserve to be placed above Shri Subrata Sengupta, Inspector (PR) and below Shri K. K. Patel, Inspector (DR), in the draft seniority list of Inspectors as on 01.04.2015. Accordingly, the seniority of Shri Majid Alam and Shri Chakreswar Sharma, are re-fixed, as under.
