

SHILLONG CENTRAL EXCISE COMMISSIONERATE

JURISDICTION: The States of Tripura, Mizoram, Manipur, Nagaland (except the Districts of Mokokchung, Longleng, Mon, Tuensang) and Meghalaya (except the Districts of East, West and South Garo Hills) and the Districts of Nagaon, Cachar, Karimganj, Hailakandi, North Cachar Hills, Karbi Anglong and Golaghat in the State of Assam.

SHILLONG CENTRAL EXCISE DIVISION

JURISDICTION: Districts of East Khasi Hills, West Khasi Hills, Jaintia Hills and Ri-Bhoi of the State of Meghalaya extending from Nongpoh to Khanapara (Them Marwet) including areas up to 200 meters (approx.) on the other side of the National Highway from Byrnihat up to Jorabat Point falling under Kamrup District, Assam and Umrangshu Circle area falling under North Cachar Hills Districts, Assam.

1.	SHILLONG	All areas falling under East & West Khasi Hills Districts and the areas beyond Umiang up to Umsning falling under Ri-Bhoi District of the State of Meghalaya.
2.	JOWAI	All areas falling under Jaintia Hills Districts of the State of Meghalaya and Umrangshu Circle area falling under North Cachar Hills District of the State of Assam.
3.	BYRNIHAT – I	Area beyond Umsning to 13 th Mile (up to Tamulkuchi Road), Byrnihat of Ri-Bhoi District of the State of Meghalaya and the area upto 500 mtrs. on the other side from the centre of National Highway 40, Byrnihat to 13 th Mile, falling under Kamrup District of the State of Assam.
4.	BYRNIHAT – II	EPIP (Export Promotion Industrial Park) area on Umtruh Road of Ri-Bhoi District of the State of Meghalaya.
5.	BYRNIHAT - III	Area from 12 th Mile (leaving the Tamulkuchi Road) on Byrnihat – Guwahati Road upto Khanapara of Ri-Bhoi District of the State of Meghalaya and the area upto 500 mtrs. on the other side from the centre of National Highway 40, from 12 th Mile to Jorabat point, falling under Kamrup District of the State of Assam.

NAGAON CENTRAL EXCISE DIVISION

JURISDICTION: The Districts of Nagaon, Golaghat, Karbi Anglong and part of North Cachar Hills District (area under Madardisha P.S. and Halflong Sub Division) of the State of Assam and the State of Nagaland (except the Districts of Mokokchung, Longleng, Mon and Tuensang).

5.	DIMAPUR	Entire Dimapur District of the State of Nagaland.

1.	SILCHAR – I	Part of Cachar District (North Bank of River Barak flowing through the Cachar District) of the State of Assam.
2.	SILCHAR – II	Part of Cachar District (South Bank of River Barak flowing through the Cachar District) of the State of Assam.
3.	KARIMGANJ	The whole of Karimganj District except Badarpur area of the State of Assam.
4.	BADARPUR	Part of Badarpur P.S. (in West up to Malua), the whole Katigora P.S., Part of Borkhola P.S., N.C. Hills District (except Umrangshu area) and the whole Hailakandi District of the State of Assam.
5.	AIZAWL	Entire State of Mizoram.
6.	IMPHAL	Entire State of Manipur.

AGARTALA CENTRAL EXCISE DIVISION

JURISDICTION: Entire State of Tripura Comprising of four Districts of West Tripura, North Tripura, Dhalai and South Tripura.

1.	AGARTALA – I	Entire South Tripura District, Sonamura Sub-Division and Bishalgarh Sub-Division of West Tripura District upto South Bank of Howrah River (Jahar Bridge)
2.	AGARTALA – II	Entire West Tripura District except Bishalgarh and Sonamura Sub-Division up to North Bank of Howrah river (Jahar Bridge) and entire Dhalai District.
3.	AGARTALA SERVICE TAX	Entire State of Tripura except North Tripura District.
4.	DHARMANAGAR	Entire District of North Tripura of the State of Tripura both Central Excise & Service Tax.
