## Terms & Conditions:-

- 1. The Departmental Auction Committee reserves the right of fixing the 'Reserve Price' of the goods being sold. The goods will be sold to the highest bidder among the bids received through sealed tenders, provided the highest bid is equal to or more than the 'Reserve Price'.
- 2. No complaint from the buyer on the quality of the goods will be entertained after the goods are sold. Goods once registered in the name of the highest bidder cannot be transferred to any other name.
- 3. The successful bidder has to deposit 25% of the Bid Amount as 'Earnest Money' immediately on completion of the auction process. The 'Earnest Money' will be adjusted at the time of the final payment of the sold goods.
- 4. The final payment of the goods has to be made within 7 (seven) days from the date of confirmation/approval of the bid. The goods sold should be removed immediately once the final payment is made.
