In exercise of Rule 130, Rule 132, Rule 133 (1) of General Finance Rule, 2017 (updated as on 31.07.2024), the office of the Pr. Commissioner, CGST Guwahati Commissionerate is hereby inviting all the identified Civil Contractors working in the construction related activity / engaged in work contracts at residential/commercial level to submit their Bids/Quotation with regard to the execution of works as detailed below.

02. Place of Work is departmental residential accommodation at Brahmaputra Apartment, Patharquarry, Narengi, Guwahati.

03. Instruction to the Contractor is provided below; -

Before submitting the quotation/bids, the contractor shall examine all specifications & conditions of this document and inspect the site. The contractors/ Agencies should quote in figures as well as in words the quantity, rates per unit and amounts tendered by them for each work as well as whole projects

04. The details of work to be performed by the Contractor is given as below; -

**Scope of Work to be undertaken**

Sl. No.	Location inside the premises	Item of Work / Description
1.	Repair of main drain inside the campus of Brahmaputra Apartment measuring 420 feet (approx.)	<b><u>Civil Work</u></b> ; <ul style="list-style-type: none"><li>Increasing the height of existing drain by 15 inches</li><li>Providing RCC slab with 3 inches thickness on top of the drain to cover the drain for safety reason</li></ul>

05. **Eligibility Criteria** to be met by the Agencies/Contractor and considered by this Department for technical evaluation of bids/quotations:

- Contractor must belong to Guwahati Station i.e. Principal place of business.
- Contractor must have a valid PAN number & GST registration.
- Contractor should have minimum annual turnover of Rs. 10.00 lakhs for last two financial year i.e. for 2023-24 & 2024-25.
- Contractor must have at least 2 year experience in infrastructure/ construction related field or engaged in work - contracts.
- Contractor should have experience of providing satisfactorily similar services to any State/ Central Government/PSU/any reputed firms in recent time.
- The contractor or Agency must declare in writing that neither he/she (in case of individual) nor any personnel of them (in case of firms/organization) is having any personal relationship to any officer in this office).
- The **contractor/nominated agency** shall be fully **responsible** for any **damage** to the departmental property as well as for any risk involved in the said work and is also liable to borne the expenditure for medical expenses if untoward incident occur at the time of work.

06. The statutory and contractual obligations to be complied with by the contractor are here as below and in violation of these obligations, this office reserve the right to cancel the contract OR withhold the certain part of payment based on the discretion of competent authority even after the award of contract.

- As the work is of utmost emergency and no delay in commencement of same will be permitted hence the nominated agency have to submit the acceptance of work order as well as commence the work on the same day.
- Interested Contractors/Agency, who may furnish their Offers against this Limited Tender Enquiry through a duly signed covering letter (by the authorized signatories) enclosing all necessary documents to Room No – 325, 3rd Floor, GST Bhawan, Office of the Pr. Commissioner, CGST Commissionerate on or before 10<sup>th</sup> March, 2026 by 1130 Hrs in person.

No communication regarding submission of quotation beyond the prescribed deadline shall be entertained under any circumstances.
