2. Brief Descriptions of works is provided in the Annexure I. The exact specification of the work may be taken from the site. The said construction work must be completed by 15.03.2018.

3. The materials such as bricks, cement, coarse sand, basins, tiles, pipes, sanitary fittings etc. should be of branded company and of standard quality. The vendors may visit the site from Monday to Friday between 09-00 hrs to 12-00 hrs for exact specification of the work. The quotation should be addressed to the Assistant Commissioner, O/o the Commissioner(Appeals), CGST, Central Excise & Customs, 5th Floor, Custom House, Nilomani Phukhan Path, Christian Basti, Guwahati-781005.

4. The tender shall be two bid systems. The Technical bids will be opened first. After screening of the technical bids, the financial bids of qualified bidders only will be opened. The terms and conditions, prescribed proforma in which information has to be given in technical bid and financial bid are enclosed as Annexure- A and B respectively.
