GENERAL TERMS AND CONDITIONS:

- 1. The firm should have GST Registration.
- 2. In case the bidders/ successful bidder is found in breach of any condition(s) of tender at any stage, legal action as per rules/laws shall be initiated against them.
- 3. Damaged and/or Expiry Date finished items will not be accepted. Supply may be done in full and no part supply will be accepted at any cost. Amount will be paid only after detailed inspection of the goods supplied to the Department by the concerned officials.
- 4. The tendering firm must quote the rates as per the Annexure -II.
- 5. No advance payment will be made. Payment will be made as electronic transfer and for the same a GST invoice should be raised in the name of the Commissioner. Central Goods and Services Tax, Aizawl showing firms the Bank A/c details.
- 6. In case any firm is already providing these items to any other Ministry/Department of Central Government, details thereof may also be furnished along with the quotations.
- 7. Bids will be finalized on grand total of rates quoted for items as per Annexure-II. However the tenderer must quote the rates of each item separately, failing which the bids shall be

- 8. Departmental officers, in order to satisfy itself, may conduct a spot enquiry to verify soundness, capability and viability with regard to capacity to execute the orders placed on the firm(s) and may also check the stores of the firm(s).
- 9. Incomplete or conditional tenders will not be entertained.
- 10. A copy of this Tender Notice, duly signed in all pages by the tenderer, in token of having understood and agreed to the conditions, should be attached along with the Technical bid.
- 11. No correspondence will be made to the unsuccessful tenderer.

TENDER PROCESS

1. Tenders are invited in two parts i.e. (i) Technical bid (ii) Financial bid.

The Technical Bid shall contain the following documents:

- a. GST Registration Certificate.
- b. A list of Proprietor(s)/Partners of the firm and their contact telephone numbers along with a certificate to the effect that the firm is neither blacklisted by any Government Department nor any criminal case is registered/pending against the firm or its owner(s)/partners anywhere in India.
- c. Copy of this tender notice duly signed with the seal of the firm, in token of acceptance of all the terms and conditions.
- d. List of the Ministries/Government Departments to whom the stationery items were being supplied by the firms. if any.
- 2. There shall be no mention of any financial matters in the Technical bid. Upon observance of any such mention in the Technical bid, the tender will be summarily rejected.
- 3. FINANCIAL BID DOCUMENT shall contain Price bid as per Annexure separately. The Financial bid will be opened only if the Technical bid is found to be satisfactory.
- 4. Bidder who has downloaded the tender from the Zonal website www.cexcusner.gov.in or the Departmental website www.cbic.gov.in. shall not tamper/modify the tender form including downloaded Financial Bid template in any manner. In case if the same is found to be tampered / modified in any manner, tender will be rejected and tenderer is liable to be banned.
