It is for information of trade and all concerned that to ensure smooth processing of new GST registration request; a Central Processing Cell (CPC) cum Training Hall has been formed in the Chief Commissioner's Office, Shillong Zone is located in the 2<sup>nd</sup> Floor of Cresens Building, M.G. Road, Shillong-793001. The Training Hall is located in nearby building i.e. Conference Room, 3<sup>rd</sup> Floor, Raps Mansion, M.G. Road, Shillong-793001. The CPC shall comprise of the following officers and shall work under the supervision of Shri H.K. Das, Asstt. Commissioner, CCO, Shillong.

- 1) Shri P.K. Sen, Superintendent, Anti-Evasion Hqr. Unit, CE, Shillong
- 2) Shri R. Hajong Roy, Superintendent, CCO, Shillong.
- 3) Shri Biplab Purkayastha, Superintendent, CCO, Shillong
- 4) Shri Mukul Gaur, Inspector, CCO, Shillong
- 5) Shri L. Jadumani Singh, Inspector, CCO, Shillong
- 6) Shri Nitish Nandal, Inspector, CCO, Shillong

The above named officers are designated as proper officers for the purpose of GST Registration. The Central Processing Cell (CPC) will have the following functions:-

- a) Application for new registration as allocated by GSTN would be processed by CPC.
- b) In the GST regime, new registration application will be split between States and the Centre. Only those allocated to the Centre would be transmitted to the CPC concerned within the CBEC.
- c) The CPC, comprising of group of proper officers who would take decision on the processing, raise query and approving new registration in a timely manner.
- d) After approving the registration, the CPC would assign the proper jurisdictional range to the new registrant before posting it back to GSTN.
- e) It will ensure that each new registration request is responded to within 3 working days as stipulated and for giving approval for the migrated assessees for generation of GSTN ID.
- f) The CPC would ensure that all taxpayers with Provisional IDs under GST regime are allocated proper jurisdictional officers (Commissionerate. Division, Range) as per local GST jurisdiction.
- g) Even in the case where taxpayer is under State administrative control, data will flow to CBEC post-approval. Such taxpayers would be assigned to a CDR jurisdiction by the CPC to ensure that jurisdictional officers are able to view the data pertaining to the above taxpayer.
- h) It will conduct training of officers (capacity building).
- i) It will endeavour to resolve issues pertaining to assesses (hand holding).
