Subject: Establishment Order No. 31/2019, dated 14.08.19 regarding transfer and posting of Group B Gazetted Officers (Superintendents) - reg.

Sir.

Kindly refer to the Establishment Order No. 31/2019, dated 14.08.19 issued vide C.No. II(3)3/ET/CCO/GHY/2019/1244-71 dated 14.08.2019 effecting the transfer and posting of Group B Gazetted Officers (Superintendents) in the Guwahati Zone.

- 2. While carrying out the transfer, officers (Superintendents) who have completed 6 years and more continuously in formations of Customs/ CX and GST or completed 6 years and more in class A city or stayed for maximum tenure in other cities as per transfer policy issued vide C.No.II(3)21/ET/CCO/S/2018 dated 16.04.2019 have been transferred. Those officers who have worked more than 80% of their total tenure in same station have also been moved out (subject to consideration of representations).
- 3. However, due to inadvertent discrepancies & omissions in data base if any officer is not covered in the transfer order but falling under the following criteria, the details of these officers along with H.O.P may be sent to CCO by 16.08.2019 for taking necessary action.
 - 4. The criteria are as follows:
 - a) Officers who have completed 6 years and more in Customs/CX-GST, without break.
 - b) Officers who have completed 6 years and more in Guwahati/Shillong. (A city).
 - c) Officers who have worked for more than 80% of their total service tenure in one single station.
 - 5. Further any representation of any officer in future shall necessarily be accompanied by their certified H.O.P, date of filing of IPR and whether any Vigilance Case is pending.
 - 6. This is issued with the approval of the Chief Commissioner.
